Location: **BEARDEN HIGH SCHOOL**      Dates: Thursday, May 25 thru Thursday, June 22

Daily Schedule: 3.5 hours, 8:30 a.m. - 12:00p.m. (Students must arrive by 8:30 and stay through 12:00 p.m.).

Fee: **\$10.00** materials fee (payable 1<sup>st</sup> day of class; fee waivers granted for eligible students)

- Process:
1. Students must review their transcript with their school counselor to decide if he/she is a candidate for the Recovery Credit program.
  2. The counselor will discuss with the student the recommended course(s) to take via Recovery.
  3. Students complete the rest of the form including student & parent signatures.
  4. Students may only take Recovery Credit classes to replace classes in which they failed.
  5. The Recovery Credit grade will be computed using the following: failing grade average, Edgenuity Quiz & Test average.

Discipline: Students that display inappropriate behavior will be removed from the program.

Transportation: Students are responsible for their own transportation.

Attendance: Students must attend regularly for 10 days, and if appropriate progress is made, students will be allowed to work from home. If students do not continue to make adequate progress, school attendance will be required.

- ❖ Students will be re-enrolled in the course if mastery is not earned. **All work must be completed by June 22 to be eligible to earn credit. If work is not completed, your work will be archived, and no credit will be earned.**

Seats are limited. Students will be enrolled on a first come, first serve basis.**
