- ----Attend one mandatory meeting (KHS Meeting is January 19, 2023 at 4:00 p.m.).
- ----Complete 8 hours of community service between November 2, 2022 July 1, 2023.
- ----Enroll at a community college or TN College of Applied Technology (TCAT) by August 2023.

Tennessee Concrete Association High School Essay Contest

Open to all high school students ages 16-18. Essay should demonstrate a student's awareness of concrete's role as a building material in homes, buildings, streets & highways OR use the prompt: How have you or your community been shaped by concrete? Essay must be typed, double spaced and not exceed 600 words. Complete online form to submit essay at www.tnconcrete.org.

Deadline: January 6, 2023

Ron Brown Scholarship - The Ron Brown Scholar Program seeks to identify African-American high school seniors who will make significant contributions to society. Applicants must excel academically, exhibit exceptional leadership potential, participate in community service activities and demonstrate financial need. The applicant must be a US citizen or hold a permanent resident visa card. The award is \$10,000 annually for four years. LOCAL COLLEGE INFORMATION/SCHOLARSHIPS

<u>University of Tennessee, Knoxville, Honors and Scholars Programs</u> (Chancellor's Honors, Haslam Scholars, Leadership Honors, and 1794 Scholars Programs)-Students who wish to be considered for UT's most competitive scholarships should apply for admission by November 1.. Once the student is admitted the link to the competitive scholarship application will become available.

Deadline: Admission-November 1; Scholarship Application- December 15

<u>University of Tennessee, Chattanooga</u>- Students must submit an application for admission and upon receiving a letter of admission, must complete an online scholarship application within 3-5 days. Priority is given to students who complete the application for admission and online scholarship application by the priority deadline of December 1. Scholarship amounts range from \$3000-\$5000; minimum GPA is 3.20 and ACT is 22. Apply early!

<u>University of Tennessee, Chattanooga- Grote Chemistry Scholarship</u>- The department of Chemistry and Physics a renewable \$3000 scholarship to three entering freshmen majoring in Chemistry. This scholarship can be added to the HOPE scholarship and other academic scholarships. To be eligible, students must earn an A or B in a high school Chemistry course, earn a 3.5 GPA, score a 26 composite on the ACT and declare Chemistry as a major. The application is online at the UTC Chemistry website.

Deadline: February 15

Middle Tennessee State University- Several guaranteed academic scholarships are available for students with a minimum 3.50 GPA and ACT 23. Amounts ranging from \$1000 to \$3000, depending on the ACT score. The ACT must be taken no later than December of the senior year to qualify for scholarships. There is no separate scholarship application. Students should apply for admission by December 1 to receive priority consideration for most scholarships at MTSU.

Deadline: Apply for admission by December 1

Buchanan Fellowship at Middle Tennessee State University - This is a competitive scholarship selected by the Honors College. Students must submit a separate application to the Honors College for this scholarship. Twenty students will be awarded a Buchanan Fellowship which provides full tuition and a book allowance. The minimum ACT is a 30 and the minimum GPA is a 3.5; a transcript and personal statement must also be submitted.

Deadline: December 1

<u>Tennessee Tech University Scholarships</u>- Tech's High Flyers Scholarship is a guaranteed scholarships for students with a 3.75 GPA and 27+ ACT ranging from \$3,000 – 5,000 per year. Apply for scholarships online through ScholarWeb. You must be admitted to apply for scholarships. Visit www.tntech.edu/scholarships for details.

Deadline: December 15

East Tennessee State University- ETSU offers a variety of guaranteed academic scholarships based on ACT and GPA (minimum GPA is 3.5 and ACT is 25). Scholarship amounts range from \$2000-\$5000. The ACT score must be submitted by March 1 of the senior year to qualify for scholarships. ETSU does not superscore for scholarship purposes. <u>Global Citizen Scholars-ETSU</u> Global Citizen Scholars are part of the Honors College at ETSU. Students with a GPA of 3.5 and a 26 ACT may apply. 25 students are accepted with scholarship. https://www.etsu.edu/honors/university_scholars/apply.php

<u>Carson Newman College</u> – All freshmen admitted to Carson Newman are considered for the Presidential, Dean's Faculty, Achievement, and Opportunity Scholarships. There is no separate application for these scholarships. Minimum GPA is 2.70 and ACT is 19. Scholarship amounts range from \$6000-\$14,000. FAFSA

To apply for federal student aid, you must complete the Free Application for Federal Student Aid (FAFSA). Federal Student Aid includes the Federal Pell Grant, Federal Work-Study, and Federal Loans. A FAFSA must also be completed to receive any scholarship money, including the HOPE Scholarship and TN Promise. It is free to complete the FAFSA.

The 2023-2024 FAFSA online opens October 1, 2022. Before you sit down to file the FAFSA, it is important that you take the time to gather all of the information you will need. Use this checklist to make sure you have everything you need with you when you get ready to file the FAFSA.

Information

- -Your email address (not your high school email) and cell phone number
- -Parent/Guardian email address and cell number
- -The month and year your parents/guardians began living in Tennessee
- -Your Social Security Number
- -Your parents' Social Security numbers
- -Your parent's dates of birth
- -Your driver's license or state ID, if you have one
- -The month and year your parents were married, divorced, or separated
- -The highest level of school your parents completed

Documents

- -All federal income tax forms (including W-2s/1099s/Schedules filed) for you and your parents
- -Most current statements from all accounts (checking, savings, investments, etc.)
- -Child support paid or received
- -Value of investments, farms or business
- -Other prior year benefits (workers comp, military, clergy, veteran amounts)

**The first step, after collecting all of the above, is to get your FSA ID (you and your parent). To create an FSA ID, go to www.fsaid.ed.gov. Keep the username and password that you create for yourself and your parents in a secure location!
