

## Knox County Schools 403b Vendor List Revised November 2015

Knox County Schools' (KCS) employees may elect to participate in tax sheltered annuity programs. The following companies have payroll slots and have complied with the tax sheltered annuity regulation that require the number of actively participating contracts to not fall below 50 on the billing cycle for April of any year. Employees wishing to participate in a tax shelter annuity program must complete the Tax Shelter Payroll Deduction/Change Authorization form. These forms are available from the Employee Benefits office, on the KCS intranet forms online database (Form #BO-121), or on the KCS website at knoxschools.org (select "Departments" then "Benefits & Employee Relations" then "Tax Shelter"). All copies of the form must be completed by the employee and sent to the Employee Benefits Department. Approved agents should also have forms available. All forms must be submitted by the 5th of each month from September through June, in order to be effective for the designated payroll. When an employee wishes to make a change in the amount being withheld, the employee *must* submit a new form with the corrected amount.
