



Knox County Schools Supplemental Vendor List Revised November 2020

Knox County Schools' (KCS) employees may elect to participate in supplemental vendor programs. The following companies have payroll slots and have complied with the regulation that requires the number of actively participating contracts to not fall below 50 on the billing cycle for April of any year. Employees wishing to participate in these program must complete the Payroll Deduction/Change Authorization form. These forms are available from the Employee Benefits office, on the KCS intranet forms online database (Form #BO-121), or on the KCS website at www.knoxschools.org/benefits. All copies of the form must be completed by the employee and given either to the agent or to Employee Benefits. All forms must be submitted by the 5th of each month from September through June, in order to be effective for the designated payroll. When an employee wishes to make a change in the amount being withheld, the employee *must* submit a new form with the corrected amount.
