- Complete a BHS DE Application and return to your counselor by March 8<sup>th</sup>
- Choose the DE course(s) that you plan to take when registering for your 2019-2020 courses on ASPEN indicate
  which semester you would like to try to have the DE course (in the "Notes to Counselor" box) & identify on your DE
  application.
- o Plan to attend a "DE Day" Meeting (specific dates TBA) when those dates are announced
  - This is a mandatory event.
  - Not attending this will result in Dual Enrollment being dropped from your Course Registration.
- Research / plan which institution that you would like to attend (PSCC / Tusculum)

#### ☐ March:

- ALL prospective DE students MUST attend a "DE Day" Meeting this is where you will complete all items needed
  to take your DE course with a representative of the college, in which you plan to enroll. At these meetings, you
  will complete the following:
  - College (PSCC or Tusculum) application
  - Dual Enrollment Grant Application
  - Immunization Forms (for respective school)
- O Dates are TBA & specific to your chosen institution
- Attendance is MANDATORY

## ☐ April / May:

- o For Fall enrollment in DE:
  - Attend a meeting with a school representative to complete your course registration (through the college's registration portal not ASPEN) & give a copy of your college course schedule to your counselor before leaving this meeting.
  - Meeting dates are TBA & specific to your chosen institution
  - Attendance is MANDATORY

#### □ November:

- For Spring enrollment in DE:
  - Attend a meeting with a school representative to complete your course registration (through the college's registration portal not ASPEN) & give a copy of your college course schedule to your counselor before leaving this meeting.
  - Meeting dates are TBA & specific to your chosen institution
  - Attendance is MANDATORY
- □ Pay any outstanding tuition or fees (time varies depending on your semester of DE enrollment)
  - You can pay through your institution (PSCC / Tusculum) portal
  - o Generally, your fees will not be applied until the term (semester) begins Fall: August, Spring: January
