Dear Hardin Valley Academy Parent or Guardian:

We will be closing this semester in a variety of ways. Students in Semester 1 courses will take End of Course (EOC) exams designed by the instructor or Knox County Schools. Students who took state-level exams will have a project or unit exam. Yearlong courses will have assignments or exams that coincide with coursework at this mid-term point. Each class will have a required assignment or exam to complete during the testing schedule listed below. These exams and activities will be graded and included in your child's grade for the semester.

Students regardless of grade level, may choose to be exempt from the final semester exam by sitting for the aligned AP/IB/AICE national exam or the approved industry credential test(s) aligned to their CTE course. If students miss or choose not to take the aligned exam, they must take the teacher-created course exam.

School will be in session until noon on Friday, December 20, we know some students will choose to leave early on Wednesday and Thursday after their morning exams. To afford your child the opportunity to leave at noon on these days, you must complete the permission slips at the bottom of this letter and have your child return them to their teachers by **Friday, December 13, 2024**. If students choose to leave at noon on these days, they must provide their own transportation and they must leave campus immediately. Please make arrangements in advance for transportation. Phone and email dismissal requests will not be permitted. School buses will not run until 3:30 pm on both days. Those students who stay for the afternoon classes must follow the schedule listed below. Friday, December 20, is reserved for students needing to make up an exam or project. Knox County Schools will provide bus transportation for the noon dismissal on Friday, December 20.

Senior Exemption: Seniors who have a minimum of a 75% average may opt out of the class's EOC exam (this exam cannot be a state, dual enrollment, dual credit, credit recovery, and IB or AP exam). You will receive additional permission slips for these course exemptions.
