ELEMENTARY SCHOOL DRESS CODE

The standards for elementary school dress reflect "common sense" and a concern for each child's comfort, safety, cleanliness, and sense of modesty. There is a strong relationship between neat, appropriate attire and a positive learning environment. Apparel or appearance which tends to draw attention to an individual rather than to a learning situation must be avoided.

To help create the best learning environment for elementary students, the following standards for student dress must be observed in all Knox County Elementary Schools:

1. Pants must not sag below the waist and must be at a safe length.
2. Head apparel, except for religious or medical reasons, must not be worn inside the school building.
3. Footwear is required and must be safe and appropriate for indoor or outdoor physical activity.
4. Clothing or accessories may not create disruption or display vulgar language or images and must not advertise products which students may not legally purchase.
5. For students in Grades 3-5, "short shorts", mini-skirts, and skin-tight outer materials without proper coverage are inappropriate attire.
6. For students in Grades 3-5, shirts, blouses, and dresses must completely cover the abdomen, back, and shoulders, and shirts or tops must cover the waistband of pants, shorts, or skirts with no midriff visible. Skin-tight outer materials are prohibited without appropriate coverage.

The school administration reserves the right to determine whether the student's attire and appearance are within the acceptable limits. In matters of opinion, the judgment of the principal/designee shall prevail.

The principal may allow exceptions for school-wide programs or special classroom activities.

The teachers and the principal will administer appropriate consequences for policy infractions.

MIDDLE AND HIGH SCHOOL DRESS CODE

The following expectations for student dress have been established to promote a safe and optimum learning environment.

Apparel or appearance which tends to draw attention to an individual rather than to a learning situation must be avoided. In matters of opinion, the judgment of the principal/designee shall prevail.

2 The following standards will be observed in all Knox County Middle and High Schools:

- 4 1. Pants must be worn at the waist. No sagging allowed.
- 5
- 6 2. Shirts, blouses, and dresses must completely cover the abdomen, back, shoulders and must have
7 sleeves. Shirts or tops must cover the waistband of pants, shorts, or skirts with no midriff visible.
8 Low-cut blouses, shirts, or tops or extremely tight tops, tube tops, or any top that exposes cleavage
9 are prohibited.

- 11 3. Head apparel, except for religious or medical purposes, must not be worn inside the school
12 building.
- 13
- 14 4. Footwear is required and must be safe and appropriate for indoor and outdoor activity.
- 15
- 16 5. Clothing and accessories such as backpacks, patches, jewelry, and notebooks must not display (1)
17 racial or ethnic slurs/symbols, (2) gang affiliations, (3) disruptive, vulgar, or sexually suggestive
18 language or images; nor, should they promote products which students may not legally buy; such
19 as alcohol, tobacco, and illegal drugs.
- 20
- 21 6. Skirts, dresses, and shorts must be beyond mid-thigh length.
- 22
- 23 7. Sleepwear, pajamas, and/or blankets cannot be worn in school.
- 24
- 25 8. Prohibited items include (1) large, long and/or heavy chains, (2) studded or chained accessories,
26 (3) sunglasses, except for health purposes, (4) sleepwear, and (5) skin-tight outer materials without
27 appropriate coverage.
- 28

29 The school administration reserves the right to determine whether the student's attire is within the limits of
30 decency and modesty. Administration should strive for consistency so the dress code is applied even-
31 handedly to male and female students.

32
33 The principal may allow exceptions in special circumstances or occasions such as holidays or special
34 performances and may further prescribe dress in certain classes such as physical education, vocational
35 classes, and science labs.

37 Any student not attired in accordance with this policy shall be subject to correction of the violation. If a
38 correction cannot be made, the student shall be subject to additional disciplinary measures as described in
39 Policy J-191 "Misbehaviors and Disciplinary Options."¹

40
41 This policy does not preclude individual schools from implementing standardized dress policies with
42 permission from the Director of Schools and the Board of Education after extensive consultation with
43 parents, teachers, and students. Any deviation from the system-wide policy must be submitted in writing
44 to the middle and high school directors for review and recommendation to the Director of Schools and the
45 Board of Education.²
