If your child scores "Approaching" or "Below" on the third grade ELA TCAP, your child will **NOT** be retained if **ANY** of the following are true:

<sup>\*</sup>Children who are suspected as having disabilities should be evaluated in accordance with the processes required for the identification of students with disabilities as outlined in the federal Individuals with Disabilities Education Act, Section 504 of the Rehabilitation Act of 1973, and state laws regarding services to students with disabilities. Those conversations, evaluations, and decisions must be reviewed for each individual child, just like any other case where a child may have a disability.

If any of these are true, your child will **NOT** be retained. If your child does not meet one of these 6-7 categories that prevents retention, families may also submit an appeal that demonstrates how their child has demonstrated proficiency in reading. Appeals must be submitted by parents/ legal guardians.



# Information for LEAs

#### Fall:

- Universal screeners administered.
- Review district-level universal reading screening data to consider effectiveness of programming and resource re-allocation.
- Update district home literacy report templates and ensure schools send home literacy reports that meet all TN Literacy Success Act expectations no later than October 5.

#### Winter:

- Mid-year universal screeners administered.
- Budget for expected participation in summer programming and tutoring and begin processes to staff, schedule, and fund those needs.
- Ensure schools send home literacy reports that meet all TN Literacy Success Act expectations and identify potential retention notification no later than February 1.
- Launch a prioritized summer camp enrollment process for third grade students at-risk of retention.

## Spring:

- End-of-year universal screeners administered.
- Ensure schools send home literacy reports that meet all TN Literacy Success Act expectations and identify potential retention notification no later than May 17.
- Finalize summer programming for any students who receive at-risk for retention notifications and continue to demonstrate deficiencies in reading.
- Administer TCAP and 3<sup>rd</sup> grade TCAP Retake (as needed).
- Provide schools with communication tools to notify parents of students who performed at the below basic or approaching levels and the various options available to them.

# Information for Schools

#### Fall:

- Universal screeners administered.
- Review school universal reading screening data to guide shifts in core instruction as well as make changes to RTI<sup>2</sup> and high-dosage, lowratio tutoring.
- Send home literacy reports in accordance with the TN Literacy Success Act no later than October 5.

#### Winter:

- Mid-year universal screeners administered.
- Review school-level data to guide shifts in core instruction and adjust students receiving RTI<sup>2</sup> and high-dosage/low-ratio tutoring for students who receive at-risk for retention notifications.
- Send home literacy reports to families and provide clear notification for those students who are at-risk for retention no later than February 1.
- Hold parent conferences and provide home resources and additional school-based support for those students who are at-risk of retention.

## **Spring:**

- End-of-year universal screeners administered.
- Review school-level data to guide shifts in core instruction, RTI<sup>2</sup> and high-dosage, low-ratio tutoring.
- Send home literacy reports to families by May
   17 with summer programming registration and resources that may support reading at home.
- Finalize summer programming.
- Administer TCAP and 3rd grade TCAP Retake (as needed).
- Administer TCAP and communicate with parents of students who performed at the below or approaching levels.
- Communicate with families regarding all options for any students who receive at-risk for retention notifications and/or who are not proficient in 3rd grade ELA TCAP.
- Support parents wishing to file an appeal in obtaining the information necessary to do so.

# Information for Families

#### Fall:

- Your child will take a universal reading screener.
- You will receive your child's home literacy report by October 5, which should include information on your child's current reading development, the support the school is providing your child in reading, and what to do to support literacy at home.
- Discuss results with your child's teacher.

#### Winter:

- Your child will take a mid-year universal reading screener.
- You will receive another home literacy report by February 1. This literacy report will also indicate whether your child may be at-risk for retention.
- Schedule a parent-teacher conference to review the results of your home literacy report, if needed.
- Sign your child up for summer programming to support their literacy development, if needed.

### Spring:

- Your child will take an end-of-year universal reading screener and the TCAP.
- You will receive a final home literacy report by May 17 which should also indicate whether your child may be at-risk for retention.
- Schedule a parent-teacher conference to review the results of your home literacy report and any necessary next steps including a testing retake opportunity, if needed.
- Sign your child up for summer programming and/or tutoring to support their literacy development.
- Review third grade ELA retake and appeals information (if appropriate).
- Collect necessary information and file an appeal (if appropriate and desired).
