May 26	<b>Raw Score to Scale Score Tables Released to Districts</b> Districts can determine student proficiency

May 30	Parent Appeal Portal Opens	
May 30 – June 13	Parent Appeal Window (Parents have 14 days to complete an appeal)	
June 7	All 3rd Grade ELA TCAP Retake Scores reported	
June 24	Final Retention notification for families (who did not participate in intervention options)	This date applies for schools starting July 24. If school starts later, notification to families must be disseminated at least 30 days before the first day of school
June 26	Launch of Post Test for Summer Programming and window for the retest	
June 30	Parent Appeal Portal Closes	
July 14	Final Retention notification for families (who participated in summer programming)	This date applies for schools starting July 24. If school starts later, notification to families must be disseminated at least 10 days before the first day of school
