

**2015 Knox County Schools' High Schools  
Virtual High School Summer School Application  
For students who attended grades 9, 10, 11 or 12 during 2014-2015 school year**

**Location:** All Knox County Schools' high schools with the exception of Career Magnet Academy at Pellissippi State

**Dates:** May 27-July 3, 2015

**Daily Schedule:** 8:30 a.m.-12:00 noon Monday through Friday

- Classes will be offered for makeup credit and new credit.

**Fee: \$10 for all courses other than Driver's Education\*:** Fees must be paid the first day of the student's summer session. The fee is non-refundable. **Exemptions:** Students receiving free or reduced-price meals in a Knox County Schools' high school in 2014-2015 may apply for exemption of class fee.

**\*\$120 for Driver's Education:** Driver's Education will be offered at only two locations: Central High School and Hardin Valley Academy. Students who wish to take Driver's Education will report to either one of these locations on the first day of class.

**Courses:** All classes will be taken online with the exception of Driver's Education. Every student will be required to attend class from 8:30 a.m. until 12:00 noon for the first 10 days. IF adequate progress is shown, the student may then choose to complete coursework from home or any remote location with internet access. All students will return to school to complete the end-of-course test. If the student fails to show continued progress while working from an off-site location, he/she will be required to return to school to complete work.

- Students enrolled in Driver's Education will attend five days of class and assigned hours of driving.
- Driver's Education Prerequisite: 15 years of age/ All students must meet state requirements for attendance and academic progress. (Is this pre-req only for driver's ed class or for summer school?)

**Courses Available:**

- English I, II, III, and IV
- Algebra I, II, Geometry, Advanced Algebra and Trig, Bridge Math
- Physical Science, Biology, Chemistry, Physics, Ecology
- U.S. History, U.S. Government, World History, Economics, Personal Finance
- AP Biology, AP Calculus, AP U.S. Government

**Make-up Credit:** Students may make up a full-unit grade of "C", "D", or "F" received by completing the online course work and the end-of-course test. Students MAY NOT repeat a course in summer school in which they earned either an "A" or a "B".

If a student does not complete the online course in the 28 days of summer school, he or she may continue the coursework with the permission of the principal. The principal will determine the date by which time the coursework must be completed.

**Grades/Credit:** A progress report will be issued at the end of the first 10 days. A cumulative numerical percent will be reported when the coursework and end-of-course test are completed. Grades will be calculated by using the Knox County Schools' guidelines for recovery credit.

- Tennessee end-of-course tests will not be administered in summer school this summer.

**Transportation:** Students are responsible for their own transportation.

**Attendance: NO ABSENCES!**

In order to earn the privilege of working at home, students must be in attendance the first 10 days.

### STUDENT INFORMATION AND RULES

All rules are strictly enforced.

1. NO ABSENCES.
2. NO EARLY DISMISSAL FROM CLASS,
3. TARDINESS. Students will be dropped from summer school on the sixth tardy. Driver's Education students will be dropped on the third tardy.
4. All students must follow rules of their teachers and obey any faculty member while attending summer school.
5. All assigned work must be completed to receive credit.
6. All fees must be paid on the first day of class or the student will not be permitted to enroll. Fees are non-refundable.
7. Students must abide by all school rules and Knox County Board of Education policy, including but not limited to:
  - Students' dress and grooming are regulated to the extent that they do not interfere with the educational process or personal safety as determined by the administration.
  - The administration will provide information about parking. Students are not permitted to return to the vehicle or the parking lot at any time except when departing for the day.
  - Students in possession of a weapon will be dropped from summer school and turned over to law enforcement.
  - Students under the influence, in possession of, or using drugs or alcohol will be dropped from summer school.
  - Students using or in the possession of tobacco products will be dropped from summer school.
  - Valuables such as money, pocketbooks, etc., are the responsibility of the student.
  - Students are not to be out of class at any time except for scheduled breaks.
  - Conduct by any student that is prejudicial to good order or discipline, as determined by the administration, may result in that student being dropped from summer school.
