What is a Title I school?

- ► Title I was passed in 1965 under the Elementary and Secondary Education Act (ESEA). It is the largest federal assistance program for our nation's schools.
- ► Title I schools receive extra funding (Title I dollars) from the federal government. These dollars are used to:
 - identify students experiencing academic difficulties and provide assistance to help these students
 - purchase additional staff, programs, materials, and/or supplies
 - conduct parent and family engagement meetings, trainings, events, and/or activities

What are my rights?

- ▶ The families and parents of Title I students have a right, by law, to:
 - Be involved in decisions made at both the school and district level
 - Be provided with information on your child's level of achievement on tests in reading/language arts, writing, mathematics, and science
 - Request and receive information on the qualifications of your child's teacher and paraprofessionals who are working with your child
 - Request opportunities for regular meetings to formulate suggestions and to participate, as appropriate, in decisions about the education of your child. The school is required to respond to any such suggestions as soon as practicably possible.

What can Title I funds be used for?

- ▶ In general, Title I funds my be used for:
 - smaller class sizes
 - additional teachers and paraprofessionals
 - additional training for school staff
 - extra time for instruction (before and/or after school programs)
 - parent and family engagement activities
 - a variety of supplemental teaching materials, equipment, and technology

How does our school use Title I funds?

- In 2021-2022, our school was allotted approximately \$366,784.72 in Title I funding.
- ▶ We developed a **Schoolwide Program**, which means we plan to spend our funds on the following:
 - > Supplemental staff:
 - 3 Teaching Assistants
 - 1 Math Coach (Master Teacher)
 - 1 New Teacher Mentor
 - 1 Instructional Support Teacher
 - 1 Part-time Certified Teacher for 1st grade intervention
 - > 12 new active panels

What is the SIP?

- ► The SIP is the School Improvement Plan. It includes:
 - the identification of the school planning team and how they will be engaged in the planning process
 - · a needs assessment and summary of academic and non-academic data
 - prioritized goals, strategies, and action steps to help address the academic and non-academic needs of students
 - teacher and staff professional development needs
 - budgets and the coordination of resources.
- ▶ The school must include family representatives on our school planning team.

What are our schoolwide program goals?

- In the next school year, students will demonstrate an increase in achievement in Reading/Language Arts/English on the TCAP state assessments to achieve our success rate AMO.
- In the next school year, students will demonstrate an increase in achievement in Mathematics on the TCAP state assessments in order to achieve our success rate AMO.
- In the next school year Belle Morris Elementary students will have equal access to a safe learning environment that:
 - 1) Promotes academic achievement.
 - 2) Limits the amount of lost instructional time.
 - 3) Ensures that all students have the opportunity to learn.

How is parent and family engagement funded?

- ▶ Any district with a Title I allocation exceeding \$500,000 is required by law to set aside 1% of it's Title I allocation for parent and family engagement.
- ▶ Of that 1%, 10% may be reserved at the district for system-wide initiatives related to parent and family engagement. The remaining 90% must be allocated to all Title I schools in the district.
- You, as Title I parents and family members, have the right to be involved in how this money is spent.

How is parent and family engagement funded?

- In 2021-2022, we received approximately \$4,805 in parent and family engagement funding. We plan to use these funds for:
 - Parent and Family Engagement Meeting and Events
 - Reading Night Oct. 26, 4:30 6:00, with Author Lester Laminack
 - Math/Science Feb. 4:30 6:30, with Steve Spangler, the science guy!
 - Materials/Supplies
 - Reading books from the author presenting, family art project, science experiment materials.

What is a Parent and Family Engagement Policy?

- ► These plans address how the district and school will implement the parent and family engagement requirements of ESSA. Components should include:
 - how parents and families can be involved in decision-making and activities
 - how parent and family engagement funds are being used
 - how information and training will be provided to families
 - how the school will build capacity in families and staff for strong parent and family engagement
- You, as a Title I parent or family member, have the right to be involved in the development of these plans.

What is a Parent and Family Engagement Policy?

- The district Parent and Family Engagement Policy can be found here:
 - » Knox County Schools Policy I-280
- This policy talks about how each Title I school will jointly develop a family engagement policy. The programs, activities and procedures will be planned with and implemented with parents of participating students.

What is a School-Parent Compact?

- A school-parent compact is a written commitment that outlines how the entire school community - teachers, families, and students will share the responsibility for improved academic achievement.
- The compact must describe how the school will:
 - provide high-quality curriculum and instruction
 - hold parent-teacher conferences, annually in elementary schools
 - provide parents with reports on their child's progress
 - provide parents reasonable access to staff
 - provide parents opportunities to volunteer
 - ensure regular two-way meaningful communication between family members and staff, to the extent practicable, in a language family members can understand
- You, as a Title I parent or family member, have the right to be involved in the development of the compact.

What is a School-Parent Compact?

- ► The school-parent compact was shared at the beginning of the school year. Students brought it home on a coral color piece of paper in both English and Spanish.
- ► The compact describes how our school, parents and students will share in responsibility for improving student academics and achievement. It details how the school and our parents will build and develop a partnership.
- ▶ Are there any suggestions for improving this compact?

What curriculum does our school use?

- The Tennessee Academic Standards provide a common set of expectations for what students will know and be able to do at the end of a grade for each subject area.
- Tennessee's academic standards form the framework for everything taught at Belle Morris Elementary

What tests will my child be taking?

- Aimsweb Reading and Math An assessment that measures fluency and foundational skills. (3 times a year)
- Mastery Connect/Case 21 Benchmarks an assessment tool teachers can use to identify student mastery of standards. (3times a year)
- TCAP/TNReady The TCAP tests are designed to assess true student understanding and not just basic memorization and test-taking skills. TCAP measures student understanding of our state standards.
- The proficiency levels students are knowing grade level standards. (below level, emerging, on level and advanced)
