



**Information for Registration:
Dual Enrollment Courses Available to HVA Students
2022-2023 School Year**

Dual Enrollment = Being enrolled at both HVA and a college

We now have several options for Dual Enrollment; most students enroll at Pellissippi:

- Pellissippi State: GPA requirement 3.0 - In Person and Online Option
- LMU: GPA requirement 3.0 - Online
- LMU Anatomy: GPA requirement 3.0 and have taken Anatomy at HVA - Online (with In Person Lab)
- Tusculum University: GPA requirement 2.75 - Online
- East TN State University: GPA requirement 3.0 and 19 composite ACT - Online
- Middle TN State University: GPA requirement 3.0 or 22 Composite ACT - Online
- Roane State University: GPA requirement 3.0 - Online
- TN College of Applied Technology: GPA requirement 2.5 - CTE Options

Pellissippi Requirements:

GPA of 3.6 or higher (uw): No test scores required.

GPA of 3.0 - 3.59: required ACT subscores

- 19 in Reading
- 18 in English
- 19 in Math
- or take placement test at the college you have chosen to take DE Classes
- For requirements for other schools, see your counselor

Students must work with their Academy Counselor when enrolling in a DE class. Students must:

- **Apply to the institution of their choice**
- **Apply for the DE Grant (see below)**
- **Be accepted as a Dual Enrollment student**
- **Register for class(es) of your choice**

March 22nd and 23rd - Pellissippi State (Spencer Joy) will be in the HVA Library to assist students who plan to attend Pellissippi with the application process.

April 12th and 13th - Pellissippi State (Spencer Joy) will be in the HVA Library to assist students who have been accepted with registering for FALL Dual Enrollment classes.

**If you plan to take courses at any other institution listed above please see your Academy Counselor for information.

Dual Enrollment Grant: Important information

PRIOR to EACH SEMESTER, in order to receive a Dual Enrollment Grant, students must apply for the dual enrollment grant through the TSAC student portal.

Qualifying for the DE Grant: to receive the Dual Enrollment Grant by meeting the admission requirements of the institution the student plans to attend.

Maintaining Eligibility Each Semester: To be eligible for a Dual Enrollment Grant for any semester beyond the first semester of receipt, the student shall continue to meet all eligibility requirements for the grant and shall achieve a cumulative college grade point average of 2.75 for all postsecondary courses attempted while participating in the Dual Enrollment Grant program. *If you do not maintain a 2.75 GPA, you will be responsible for tuition.*

NOTE: The corresponding grades for the postsecondary credit hours taken as a dual enrollment credits shall not be included in the postsecondary cumulative grade average for purposes of the Tennessee HOPE Scholarship program.

Dual Enrollment Grant Funding Requirements:

1. A student qualifies to receive the Dual Enrollment Grant for one course per semester by meeting the admission requirements of the institution the student plans to attend. To receive funding for up to two (2) additional courses per semester, the student

At a TN public high school or Category 1, 2, or 3 private high school must achieve a high school GPA of at least 3.0 or attain a minimum ACT composite score of 21 or a concordant equivalent score on the SAT. *ACT Superscore results are not accepted.*

2. Dual enrollment students enrolled in [high-need courses](#) or programs as part of the Governor's Investment in Vocational Education (GIVE) Act may receive higher funding amounts for up to four (4) courses under the following limitations

- Funding does not exceed the cost of maintenance fees established for community colleges by the state university and community college system; or
- Funding does not exceed the cost of maintenance fees associated with the average attempted clock hours weighted by program participation for Tennessee College of Applied Technology (TCAT) institutions, as determined by the state university and community college system.

3. Students may receive Dual Enrollment Grant funding for up to ten (10) courses over their junior and senior years. Students who receive funding for more than four (4) dual enrollment courses will have all amounts awarded for courses five (5) through ten (10) reduced from their Tennessee HOPE Scholarship on a dollar for dollar basis beginning **with the first semester of college enrollment**, and even the following semester of enrollment until the borrowing requirement is satisfied.

NOTE: please see funding formula below (first four DE courses are granted up to \$543 per course; courses 5-10 are granted \$100 per credit hour (basically, \$300 per course and the students pays the difference).

4. The number of years enrolled as a dual enrollment student does not count against the statutory five (5) year limitation for the Tennessee HOPE Scholarship program.

5. At 2-year and 4-year postsecondary institutions, the Dual Enrollment Grant shall not be used for upper division courses (generally numbered 300-400 or 3000-4000).

Dual Enrollment Courses 1 – 4 (Beginning with the Spring 2022 Semester)

- At an eligible 2-year and 4-year postsecondary institution, the first four dual enrollment courses may be awarded up to \$543 per course.
 - Dual enrollment students may receive up to \$513 per course for the first four high-need courses taken as part of the GIVE Act.
- At a TCAT, the first four dual enrollment courses are paid:
 - Up to \$206 for 1-40 clock hours

- Up to \$196, if one of the first four high-need courses as part of the GIVE Act
- Up to \$284 for 41-80 clock hours
 - Up to \$264, if one of the first four high-need courses as part of the GIVE Act
- Up to \$429 for 81-135 clock hours
 - Up to \$399, if one of the first four high-need courses as part of the GIVE Act

Note: Students can be paid up to four GIVE (high need) courses within the ten-lifetime course limit. GIVE course(s) paid in Courses 1 – 4 will reduce the number of GIVE courses paid in courses 5 – 10.

Dual Enrollment Courses 5 – 10 (Beginning with the Spring 2022 Semester)

- At an eligible 2-year and 4-year postsecondary institution, courses 5 – 10 will be paid at \$100 per credit hour
 - Unless any GIVE (high need) courses were paid among courses 1 - 4, students may receive \$513 per course, not to exceed four high need courses paid within the ten-lifetime course limit
- At a TCAT, courses 5 – 10 are paid:
 - Up to \$100 for 1-40 clock hours
 - Up to \$196 as part of the GIVE Act, unless any high need courses were paid among courses 1 – 4, not to exceed four high need courses paid within the ten-lifetime course limit
 - Up to \$200 for 41-80 clock hours
 - Up to \$264 as part of the GIVE Act, unless any high need courses were paid among courses 1 – 4, not to exceed four high need courses paid within the ten-lifetime course limit
 - Up to \$300 for 81-135 clock hours
 - Up to \$399 as part of the GIVE Act, unless any high need courses were paid among courses 1 – 4, not to exceed four high need courses paid within the ten-lifetime course limit

Note: Any award amount received for courses 5 – 10 will be deducted from the student's HOPE Scholarship beginning with the first semester of college enrollment, and even the following semester of enrollment until the borrowing requirement is satisfied.
