**Disclosure/Release Form for Prom Attendance**

**Required with ticket to the Prom!**

It is my decision for my student (me) to attend the Prom sponsored by **Fulton High School** in the **Knox County Schools (KCS)** system. I understand and I agree to the following terms in order for \_\_\_\_\_ to attend the **Fulton High School Prom**, and I am also releasing **Knox County Schools** their affiliates, successors and assigns, officers, employees, representatives, partners, agents and anyone claiming through them (collectively, the "Released Parties"), in their individual and/or corporate capacities from any and all claims, liabilities, obligations, promises, agreements, disputes, demands, damages, causes of action of any nature and kind, known or unknown, which you or your child/student has or ever had or may in the future have against Releasee or any of the Released Parties arising out of or relating to the participation in prom or in KCS in general.

**Please initial:**

\_\_\_\_\_ My student (or me as the student) has had no symptoms (fever, cough, rash on feet, shortness of breath, diarrhea, or headache) of COVID-19 for the past 14 days.

\_\_\_\_\_ No one in our home has been medically diagnosed with COVID-19 in the last 14 days.

\_\_\_\_\_ I have the duty to notify you if someone in my home does test positive for COVID-19 at any time after the date of this form, as well as keep my student at home for 14 days after the positive test before he/she can attend the prom.

\_\_\_\_\_ If my student (I) should experience any of the symptoms of COVID-19, I will keep him/her at home.

\_\_\_\_\_ If my student (I) experiences the symptoms of COVID-19 for 2 or more days, I will have him/her tested for COVID-19 and understand I will need to provide a negative test or doctor's note for him/her to attend the prom. If his/her results are positive, I understand he/she will need to remain at home for at least 10 days.

\_\_\_\_\_ Prom venues are not offering refunds to those who are not able to attend and payment may be considered a school donation.

\_\_\_\_\_ I have read and understand this form and had the opportunity to ask questions and discuss these requirements further before signing this form.

**What staff and students will do to stay safe:**

- Teachers and students will take temperatures with a no touch thermometer at sign in/arrival (if KCS still requires such). Students or teachers with a temperature of 100.4 deg. or above will be asked to not attend the prom. (Using Thermoworks Wand or similar)
- Clean or used pens for sign in/general use will be available.
- Hand sanitizer or hand washing will be used once students arrive.
- Students will be required to wear masks pursuant to KCBOE Policy C-240 Face Coverings.
- Surfaces will be wiped down before attendance and as necessary.
- Students will be asked to maintain protocols in the same manner as a school day with more flexibility in outdoor spaces.
- The capacity of the venue will be more limited due to COVID-19.
