I understand my child must be present the entire time in order to be eligible to try-out.

I understand my child will be evaluated by qualified, impartial judges, and we agree to abide by the decision of the judges.

If my child is selected for the squad, I understand cheerleading must take top priority over any other sport, job, vacation, camp, etc. I understand my child must be present at ALL practices, games, team events, and other required activities. I understand he/she must abide by the rules and regulations set forth by the cheer coach(es) and ethics/principles of Gibbs High School.

I also understand there will be a significant financial obligation if my child makes the squad. A general estimate of cost is approximately \$500-\$1,000 (this includes camp, camp wear, shoes, socks, briefs, bows, poms, etc.). I also understand my participation in fundraising activities will be *required* throughout the year.



I understand if I am selected for the squad, I must abide by the rules and regulations established by the coach(es) and the administrators of Gibbs High School, and I must attend ALL practices, games, and other required activities not otherwise specified. There will be no exception for missing either practices or games (exceptions: deceased family or illness with doctor documentation), as cheerleading must take top priority over any other activities.
